O R D E R U/S.80G(5)(vi) OF THE INCOME-TAX ACT,1961 READ WITH RULE 11AA OF INCOME-TAX RULES 1962 :

By an order of even no. and dated 20.12.2007, the applicant has been granted approval u/s 80G of the Income-tax Act by the Commissioner of Income Tax-II, Trichy from 30.04.2007 to 31.03.2009. The application in Form No.10G filed on 07.07.2009 is hereby considered for the purpose of continuance of approval u/s.80G(5) of the Act.

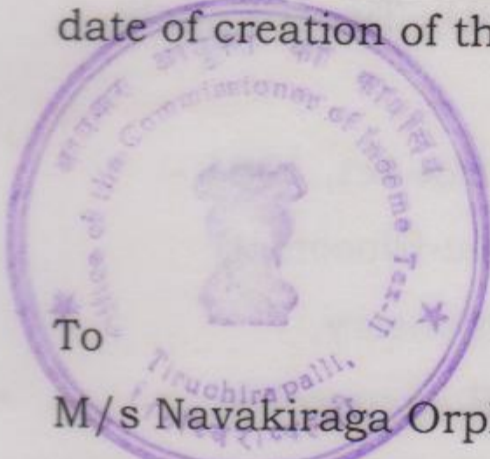
